Dear Mr. Chairman:

The FY 2002 Supplemental Appropriations Act for Further Recovery from and Response to Terrorist Attacks on the United States contained two rescission provisions, totaling \$395 million. Section 1403 of P.L. 107-206 rescinded \$350 million from prior appropriations for administrative and travel accounts from executive branch agencies. Section 803 of the Act rescinded \$45 million for administrative and related expenses for certain departmental management accounts from amounts available under the FY 2002 Departments of Labor, Health and Human Services, Education, and Related Agencies Appropriations Act (P.L. 107-116).

This report fulfills the Act's reporting requirements contained in those provisions. Table 1 displays the rescission amount by account for each agency subject to the section 1403 rescission. Table 2 displays the rescission amount by account for each agency subject to the section 803 rescission. Amounts rescinded under section 1403 were calculated based on the amount of administrative and travel related obligations estimated for FY 2002 for each executive branch agency. Each agency was then assigned a total rescission amount based on its pro rata share of obligations and each agency distributed the rescission amount to its accounts.
